

IEUME User manual for the eLearning platform

Overview:

The IEUME consortium has taken concrete steps to develop an innovative training programme to assist migrants to develop important skills and knowledge that will help them in their integration process. This training programme, comprised by a gamified curriculum and mini games, walks them through important aspects of the European civic life, supporting them to acquaint themselves with Institutions of the EU and the European Cultural Heritage, understand key aspects in regards to their Access to Rights and Civic Participation as well as take concrete steps in pursuing employment in their host country.


The learning material can be accessed through the eLearning Platform of the project that has been developed in a manner to ensure an easy to use and fun user experience that will help users to browse through the contents of the eLearning platform. Through the learning platform they can take study at their own pace the content and modules of the curriculum and/or test and sharpen their understanding of the issues presented via the mini games. The mini games are scenario-based mini quizzes in Basic, Intermediate and Advanced level, that users can play and progress, getting badges, as they complete them.


